A PKI uses the concept of a single, trusted introducer. Instead of securely exchanging all public keys among all devices, only the public key of the trusted introducer has to be securely distributed to all devices. This exchange is usually done

by downloading the public key and then verifying it out of band.

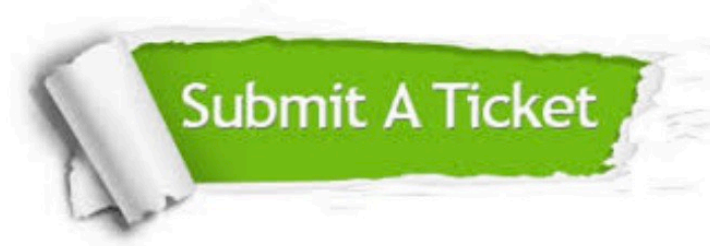
