You are a planner in a community with a new sign ordinance that prohibits banners from being strung across the road. The ordinance was adopted in response to several unattractive advertising banners that had frequently been strung



local roads and often become entangled with electrical wires. On your way to work one morning, you see that a community group has strung a banner across the main street that advertises an upcoming charity event that will generate

thousands of dollars for needy families. You know that the money is greatly needed and that local officials and residents support the event.

What might you do in the short term?

A. Answer: See the solution below

Correct Answer: A

Since it is your duty to enforce the ordinance immediately, you might want to think of some alternatives to suggest to the event organizers, such as stringing the sign between two buildings on the same side of the road. However, note that such a solution might have undesirable ramifications, such as a proliferation of signs being strung between buildings. Another way to confront the situation honestly would be to encourage the community group to apply for a variance. If a variance were granted, then there would be no question about allowing the banner to remain in place.
